9	Program advisory committee	<ul> <li>Composition and functions of the Committee</li> <li>Report on the Committee's performance and outcomes</li> </ul>
10	Key performance indicators and benchmarking	• A report on program's key performance indicators' measurement and benchmarking for the last three years.
11	Program self-study	<ul> <li>program self-evaluation scales (taking into consideration that the level of evaluation is not less than three points for each of the main criteria identified by the Center and for each standard)</li> <li>program self-study report</li> <li>Evidence for the self-study report.</li> </ul>

12	Operational plan for scientific research and its follow-up	<ul> <li>Operational Plan for scientific research in the program (depending on the nature of the program)</li> <li>System for monitoring and documenting the scientific research activities of the program</li> <li>Periodic performance reports of the scientific research plan</li> </ul>
13	Scientific supervision system on theses, projects, or vocational training	<ul> <li>Guides, regulations, and procedures for scientific supervision of theses, projects or vocational training</li> <li>Follow-up scientific supervision reports in the program</li> </ul>
